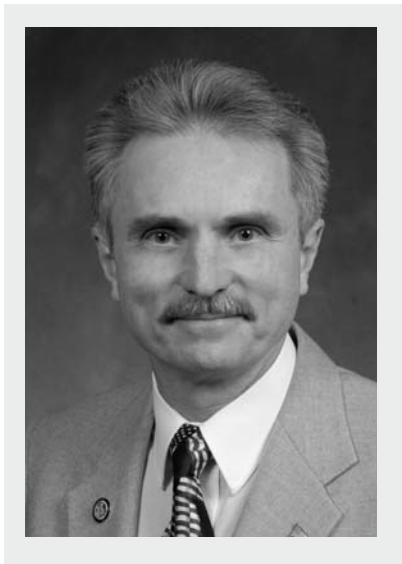

REP. DON PRIDEMORE'S SURVEY

1. Virtual schools allow students to learn on-line at home under the supervision of a parent or guardian. The student and parents are under the direct supervision of a certified teacher who is employed by the school district. The cost per student of these programs is about half of a brick-and-mortar school.

These schools enjoy a great deal of flexibility and are exempt from most of the mandates that the state imposes on traditional schools. Charter schools have been part of Wisconsin's statutes since 1993.
