The Wisconsin State Legislature has begun the 2007 session and is preparing to address a challenging budget. The state is facing a \$1.7 Billion budget deficit, in large part due to new agency requests. The legislature will need to work in a bi-partisan manner to identify priorities and exercise fiscal responsibility.

The good news is that the Wisconsin economy is strong. The Legislative Fiscal Bureau estimates the state will have \$1.25B in new revenue over the biennium. New revenue growth tells us what government can afford without raising taxes or increasing fees.

Communication with local community leaders and constituents is essential in order for me to effectively represent our district. Your input and direction is very important to me. 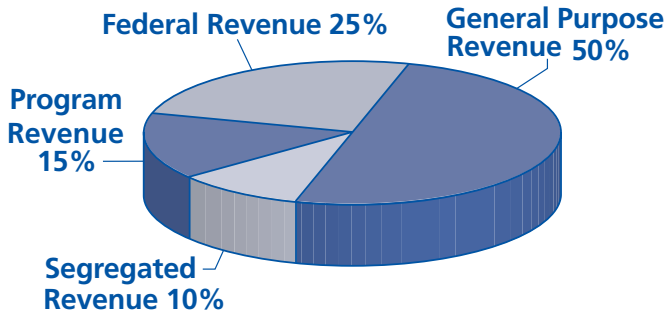
- 1) Should health care providers be required to provide consumers with the actual costs of all health care related procedures and practices?

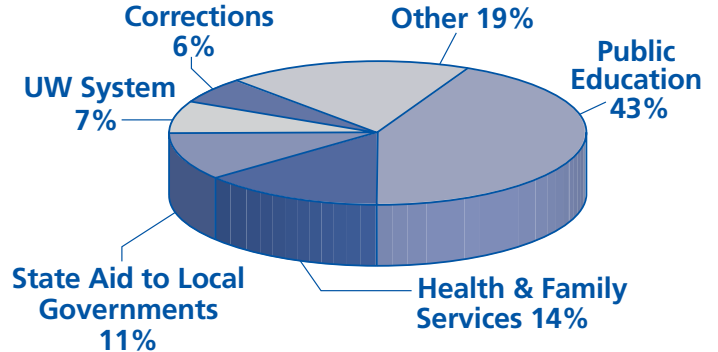
